Scan Invoices ▶▶

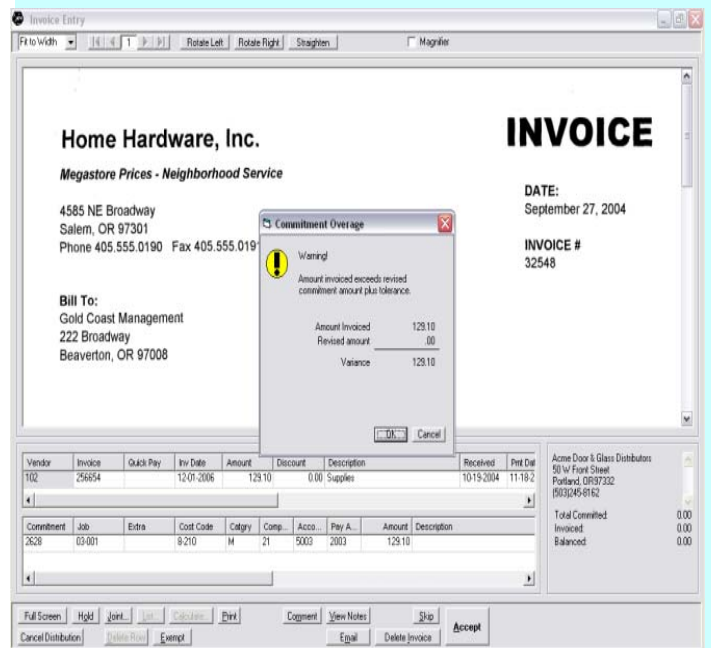
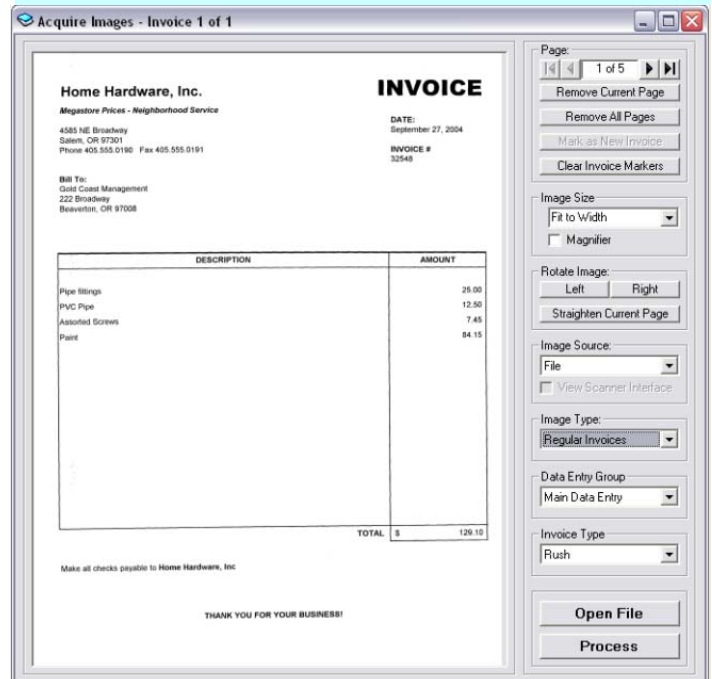
- Comes with scanning software. It's easy to capture an invoice and all supporting documents in one record
- Highly automated batch scanning. No need to code, categorize, name or route invoices. TimberScan automates all that.
- Supports regular invoices, recurring invoices, purchase orders, receiving tickets, packing slips, lien waivers, etc
- Automates rush or priority invoices
- Checks can be scanned and automatically attached to invoice record
- **TimberScan Mobile** allows you to use your phone camera to capture receiving tickets and other documents and automatically send them into TimberScan

Initial Coding ▶▶

- Data entry is exactly the same as in Timberline with the same lookups, warnings, error messages and distribution grids.
- Supports multi-line distributions and multiple approvers per invoice

Automatically Routes Invoices ▶▶

- Automatically routes images to the right person based on your business rules.
- Supports multiple Timberline data folders
- Notifies approvers automatically that invoices require their approval – this is optional by user



Process and Approve ▶▶

- The approver simply opens TimberScan and sees the invoices, PO's and other supporting documents associated with each invoice
- Supports multiple approval levels based on user defined dollar thresholds
- Has built in e-mail linked to both Timberline's Address Book and Outlook for ease of use. Automatically attaches invoice as PDF
- Approver can route to another approver, reject invoice or put on hold
- **ONLY APPROVED invoices can be paid**
- Invoices coded and approved in TimberScan automatically flow to Timberline without duplicate data entry
- **TimberScan Mobile allows you to approve invoices on your G3 phone. (Optional)**

- TimberScan reports drill down to invoice level
- Invoices are automatically attached to the Timberline invoice record so you can view invoice images directly in Timberline
- TimberScan reports are extremely powerful. They can show all invoices from both TimberScan and Timberline on one report.

- **Custom reports can be created using our report designer – TimberScan Query**

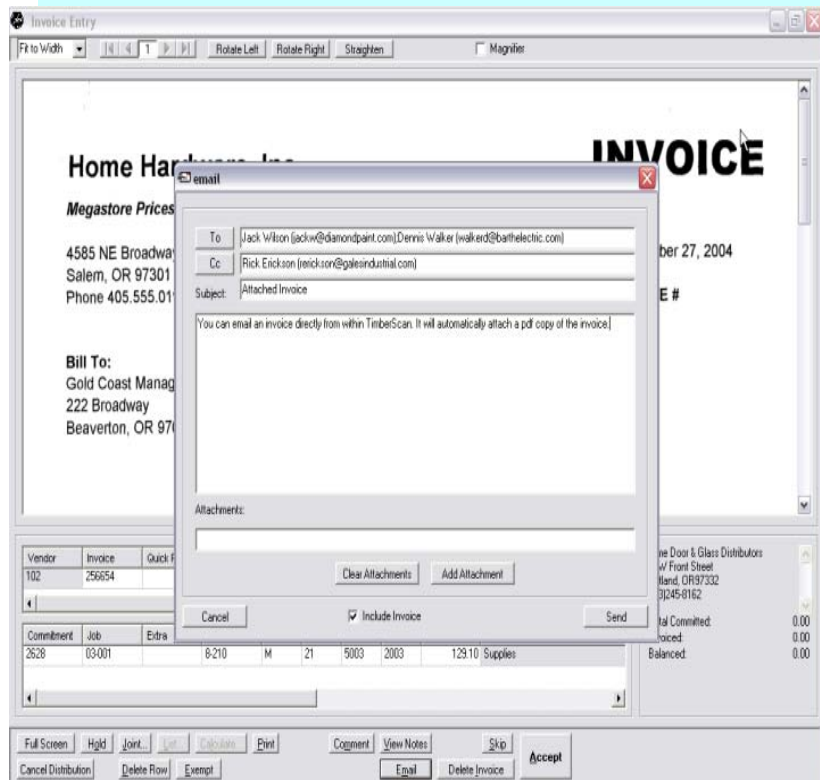
Security and Data Integrity ▶▶
